TERMS AND CONDITIONS - 条款

1. A deposit equivalent to 50% of total expenses will need to be paid within 3 days of the date of confirmation of the order or before the date of the function whichever is the earlier.
2. The remaining 50% shall be paid before the date of the function.
3. For payment by Credit Card
An imposition of 2.0% charge is required on the Total Bill if payment made "After" the Function / Event.
If payment made "Before" the function/ event, 2.0% charge shall be waived.
4. If customer fail to pay the full bill as above mentioned, there will be an imposition of 2.0% per month on the outstanding payment which calculated from the date of the event.
5. If customer wish to borrow any utensil, equipment and table cloth after the function/ event, he/she needs to inform our customer service and a refundable deposit is required.
 - 5.1 For Equipment, a deposit of RM50.00 is required per piece of equipment.
 - 5.2 For Table Cloth a deposit of RM20.00 per piece is required.
6. An additional transportation cost of RM50.00 needs to be added on top of the total bill for collecting the borrowed items & payment.
7. For any cancellation less than 30 days, the customer must inform/notify the customer service.
 - 7.1 If notification period is less than 30 days, the following penalty charges will be imposed:
Less than 07 days prior to event date : 100 % of the total estimate amount
Less than 14 days prior to event date : 75 % of the total estimate amount
Less than 21 days prior to event date : 50 % of the total estimate amount
Less than 30 days prior to event date : 25 % of the total estimate amount
8. Upon receiving our confirmation letter, the customer shall revert and confirm the buffet menu, number of persons, date & Time and venue of the function 10 days before the event.
9. Any change in the buffet menu dishes, number of person (No of guest), time, date and venue and/ or any agreed terms shall be sole discretion of Bamboo Catering. Bamboo although we shall not spare every reasonable effort to accommodate the changes.
10. In the event of any delay due to unforeseen circumstances, time adjustment will be at the discretion of Bamboo Catering Management.
11. If customer request for an extension of the event time, there may be an imposition of overtime charges to cover the additional time requested as 1 hour per server RM 10.
12. Bamboo Catering Shall not be liable, either in part or wholly, for the non-performance or a delay due to Force Majeure beyond the control of Bamboo Catering.
13. Customer agrees to hold Bamboo Catering harmless and not responsible for the loss of, or damage to their personal property in the Customer premises.
14. Price are subject to change without prior notice.
15. Bamboo Catering will not be responsible for any adverse conditions brought by the outside vendor by the owners into the event. Non Halal food is not allowed during the event. **Please Sign Here For Notice**
16. If you choose to select the food items on line, the submission of food list does not constitute in itself a contract between both parties and the receipt of the same by us is not to be taken as an acceptance notice until our marketing division issues our Company's Confirmation Number. Although we will make every endeavor and best efforts to accommodate your orders, our company reserves the right to accept or reject your proposal based on availability of menu items and your proposed date.
