B. Input from PDC

PDC interested to adopt 3 Containers as below:

i. Prangin Mall Container Arts

- To shift to BKIP Entrance Bandar Cassia.
- To add PDC logo on the container.
 - CCPA to explore the possibility

ii. Aspen Vision City

- To shift to Sales Gallery Bandar Cassia
 - estimated to transfer in March or April 2021
- To request a lower rate of relocation fee as the location that they are going to relocate is is very near to the current location.
 - Mr Tan stated it is not possible as it is rented by day, not by distance
- If everything is okay, they will move the Aspen Container first in March or April 2021.
- To add PDC logo on the container.
 - CCPA to explore the possibility

- iii. Dataran Pemuda Merdeka
 - To shift to Roundabout at Stadium Batu Kawan.
 - Container structure at DPM is not suitable to place at roundabout.
 - PGT to discuss with PDC and come out on new artworks related to PDC.
 - To inform PDC to refer to the 2 options provided by CCPA
- iv. Balik Pulau & Karpal Singh Drive
 - PDC will discuss with the industries near Batu Kawan area which land the industries are able to give to PDC.
- v. Others
 - To have a meeting with PDC to negotiate for costs lower than RM398k.
 - To arrange a meeting with PDC to discuss in detail. To have the meeting at Batu Kawan to receive the site.
